Care aides under pressure, and at risk, in efforts to provide quality care to nursing home residents and patients, according to poll

The 46,000-member Hospital Employees' Union represents approximately 15,000 care aides in British Columbia.

HEU commissioned Viewpoints Research to carry out a random telephone survey of its care aide and community health worker members on a range of issues related to care delivery and health and safety.

With a sample size of 602, the poll is accurate to within +/- 3.9 percentage points, 19 times out of 20. The survey was conducted between September 16 and 25.

Care aides are typically employed in residential and long-term care, nursing homes and extended care facilities with an increasing number being utilized in acute care settings. They provide the bulk of personal care to residents including bathing, toileting and dental care.

The survey sample also includes a smaller number of community health workers who provide similar care but in home visits. Care aides and community health workers are also sometimes referred to as Health Care Assistants.

Here are some of the results of the survey.
