Re: Invitation to apply for Prevention Steward pilot project position (1 position)

I am inviting interested HEU members from the Facilities Subsector working in **Island Health** to apply to be a **full-time Prevention Steward.** Applicants <u>must be qualified</u> in the area of occupational health and safety.

Applicants must hold **full time status** with the Health Authority. In recognition of staffing challenges due to the COVID-19 pandemic, Prevention Stewards will not be selected from a long term care or assisted living facility; nor will they be a Medical Device Reprocessing Technician.

A job description outlining the roles, responsibilities and qualifications is attached.

Background

In 2019, the Facilities Bargaining Association (FBA) negotiated funding to implement a Prevention Steward pilot project. The funding allows for one (1) prevention steward position in each of the two health authorities – Vancouver Coastal Health (VCH) and Island Health (IH) – for a period of two years with a possible further extension of an additional year.

This application package is for the pilot project that will be based out of **Royal Jubilee Hospital**. The project will allow us to demonstrate the important collaborative role prevention stewards can play in supporting and developing FBA Joint Occupational Health & Safety (JOHS) committee members in their important work. Prevention stewards will provide Facilities members with resources to resolve workplace health and safety problems. In addition they will work with employers on health and safety initiatives aimed at reducing hazards in the workplace.

Prevention stewards' wage rates and benefits will be matched to their existing classification and increment step under the Facilities Collective Agreement. Relocation costs are not provided as part of this arrangement, so applicants should be within daily commuting distance of **Royal Jubilee Hospital**. The prevention steward will return to their regular position and or casual list upon completion of the project.
