# Constitution and By-Laws

## REVISED 2018

### **Article 15, Section A**

LOCAL OFFICERS: The Officers of the Local shall consist of Chairperson, Vice-Chairperson, Secretary-Treasurer, Assistant Secretary, Conductor, Warden, three (3) Trustees and, in the event of merged Locals, such other Local Officers that ensure worksite executive representation.

Individual Locals may vary their Executive structure subject to prior approval of the Provincial Executive.

### **Clarification of Trustee Positions**

Each Local must have three (3) Trustees.

The Trustee positions are as follows:

- Senior Trustee\* (serving second year of a two-year term)
- Senior Trustee-Elect (two-year term – after first year moves up to the Senior Trustee)
- Trustee

\*If the Senior Trustee Elect does not carry on for their second year, the Local will be without a Senior Trustee and the Local must then elect a second one-year Trustee. The only way for a member to hold the Senior Trustee position is to move in to it after they have served one year as the Senior Trustee-Elect. In this case, the Trustees would be as follows:

- Senior Trustee-Elect (2-year term)
- Trustee (1-year term)
- Trustee (1-year term)
