58th BC Federation of Labour Constitutional Convention Re:

The BC Federation of Labour will be holding its 58th Constitutional Convention at the Vancouver Convention Centre (East) on November 26 – 30, 2018

This year, HEU will be sending a total of **142 delegates**, which includes the Provincial Executive members. HEU's three (3) full-time officers will also attend as automatic delegates from the Executive Council of the Federation. The number of delegates may be subject to change.

The BC Federation of Labour will be holding a Human Rights/Diversity Forum and Young Workers Forum on Sunday, November 25, 2018. Further details will be provided at a later date.

Please ensure delegate selection for the BC Fed Convention is included on your September Local meeting agenda. Delegates must be elected at a meeting with quorum, but if necessary, the election process can also be done at a special meeting. Please note that all delegates/alternates must also meet the eligibility requirements as outlined in Article 4 of the HEU Constitution and By-laws. In cases where you are electing more than one (1) alternate, please list in order of their election.

We encourage Locals under 250 members to apply. This year we will begin our small Local rotation selection with the Fort Nelson Local, and proceed alphabetically through Locals of under 251 that have applied, until we have filled all the credentials that are available. Locals of 250 members or less are asked to elect one (1) person, plus one (1) alternate, who will attend as a delegate if their Local is selected in the rotation.

The actual number of Locals selected in the small Local rotation is dependent on the number of credentials left after the Locals of 251 or more members receive their credentials.

The attached delegate entitlement list is based on the average number of dues paying members for the six (6) month period of January 2018 – June 2018.

Please ensure that the attached delegate/accommodation form is completed in full, signed by both the Chairperson and Secretary-Treasurer of the Local, and returned to Provincial Office, attention of Candice Klein via fax: 604-739-1510; email: cklein@heu.org; or mail: HEU, 5000 North Fraser Way, Burnaby BC, V5J 5M3 no later than noon, Thursday, October 11, 2018.

Local delegate entitlement is determined by the number of members in your Local as per Article 8 of the HEU Constitution and By-laws, as follows:

0 – 250	(Members selected on a rotational basis in

251 – 350 members	1 Delegate
351 – 450 members	2 Delegates
451 – 600 members	3 Delegates
601 – 800 members	4 Delegates
801 – 1000 members	5 Delegates
1001 – 1200 members	6 Delegates
1201 – 1400 members	7 Delegates
1401 – 1600 members	8 Delegates
1601 – 1800 members	9 Delegates
1801 members & over	10 Delegates

HEU will cover wages, travel, accommodation, per diems, dependent care and the registration fee as per HEU policies.
