It's hard to believe another two years have gone by since our last convention. The biggest challenge


for the clerical subcommittee was deciding our mandate during our two-year term.

We drew from HEU's 2010-2012 Strategic Directions document, which was adopted by 2010 convention delegates. Part of the document was HEU's commitment to tackle bullying in the workplace. In

Other projects

We produced our popular clerical mousepads, featuring "Fredrica" wearing her anti-bullying T-shirt and the word UNITY in five different languages, to promote solidarity among HEU's diverse membership.

Were you one of the lucky members who attended the third clerical occupational conference in the fall of 2011? About 90 clerical members spent two days comparing notes and identifying



bargaining demands to take to the facilities bargaining table.

We ran a contest to give an updated look to our clerical mascot "Fredrica" after members communicated that she needed a more modern feel. It was also our chance to have some fun. We received 265 entries. The winner of the E-Vox e-reader was drawn on May 1 at the Vancouver Coastal regional conference: **Ruth Monge**, health records, Victoria General Hospital. The new "Fredrica" will be featured on a new clerical mug, which will be available next month.

The subcommittee also gave support to the 130 medical transcriptionists in the Lower Mainland, whose jobs are being threatened by contracting out. 
